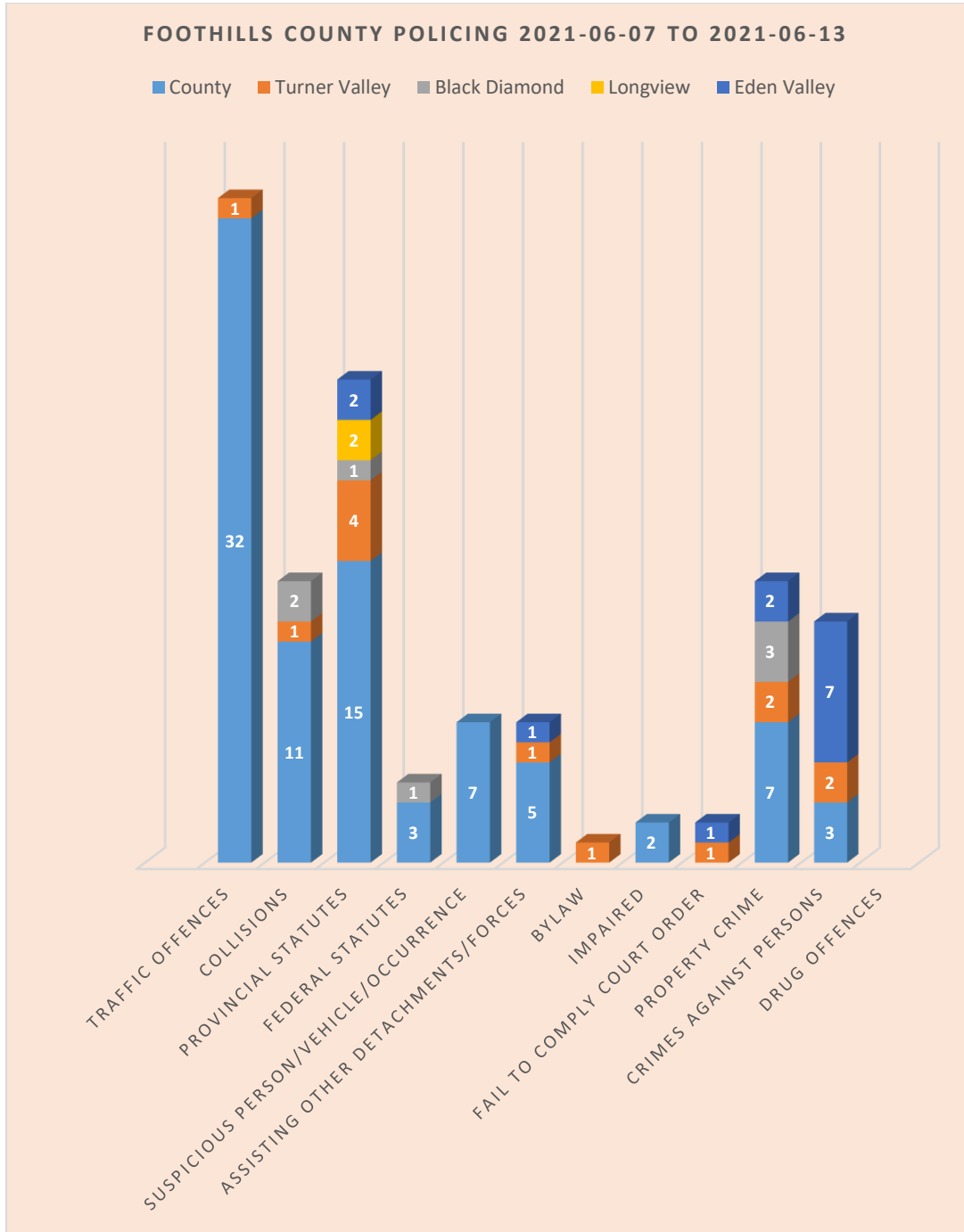

#### **Q&A WITH S/SGT LAURA AKITT**

I wanted to take a moment and personally thank everyone who took the time to complete the on-line policing survey this spring as part of the Detachment Annual Performance Plan. I am happy to report that we had over 200 responses this year, which has provided helpful insight to the initiatives the Foothills County will be actively working towards this fiscal year.

Based on your responses, the three key area's which will be addressed are;

**Crime Reduction** – With a focus on reducing property thefts. One key actively to help us work towards this goal is the active CAPTURE program. I believe to date, we have almost 20 participants in the program. The availability of your security video is vital to our investigations.

**Traffic Enforcement** – Foothills County RCMP will be conducting targeted traffic enforcement in high volume areas though out this year, on high traffic locations as well as areas of construction. We are working together with the Foothills County CPO's to achieve this goal.

**Police Presence / Visibility**- Covid -19 has made it extremely difficult to maintain a number of personal interactions with Partner agencies and organizations. As we continue to move towards a full re-opening, I am optimistic that we will be able to start to hold our in person activities soon. On June 12, 2021 at approximately 11:50pm, Foothills County RCMP received a complaint from the Edmonton Flight Center of a high intensity flashlight being pointed at an airplane in flight for over 5-minutes in 30-second intervals, which occurred approximately 3 nautical miles west of High River. This serious Criminal Code investigation is on going. Anyone who has information regarding this offence is asked to contact the Foothills County (High River) Detachment.

On June 14, 2021, Foothills County RCMP received a complaint of two motorcyclists stopped at the Highway lookout area west of the Sandy McNab Equestrian camp drinking beer. Foothills County RCMP made patrols of the location and located two motorcycles matching the description. A traffic stop was conducted, which resulted in both motorcycles being towed from the location and the drivers charged provincially for Operating a Motor Vehicle without a Class 6 licence as well as No Registration.

On June 15, 2021 at approximately 6:15am, Foothills County RCMP, Fire and EMS responded to a collision southbound on Highway 2 near Dunbow Road. A 28 year old female driver and lone occupant of a pick up truck was travelling southbound on Highway 2 in the passing lane when it struck a stationary Freightliner parked off to the side of the roadway. STARS Air Ambulance airlifted the female to Calgary Foothills Hospital in serious but believed to be non-life threatening condition.

Traffic on Highway 2 was stationary for approximately two hours while emergency personnel worked.
