



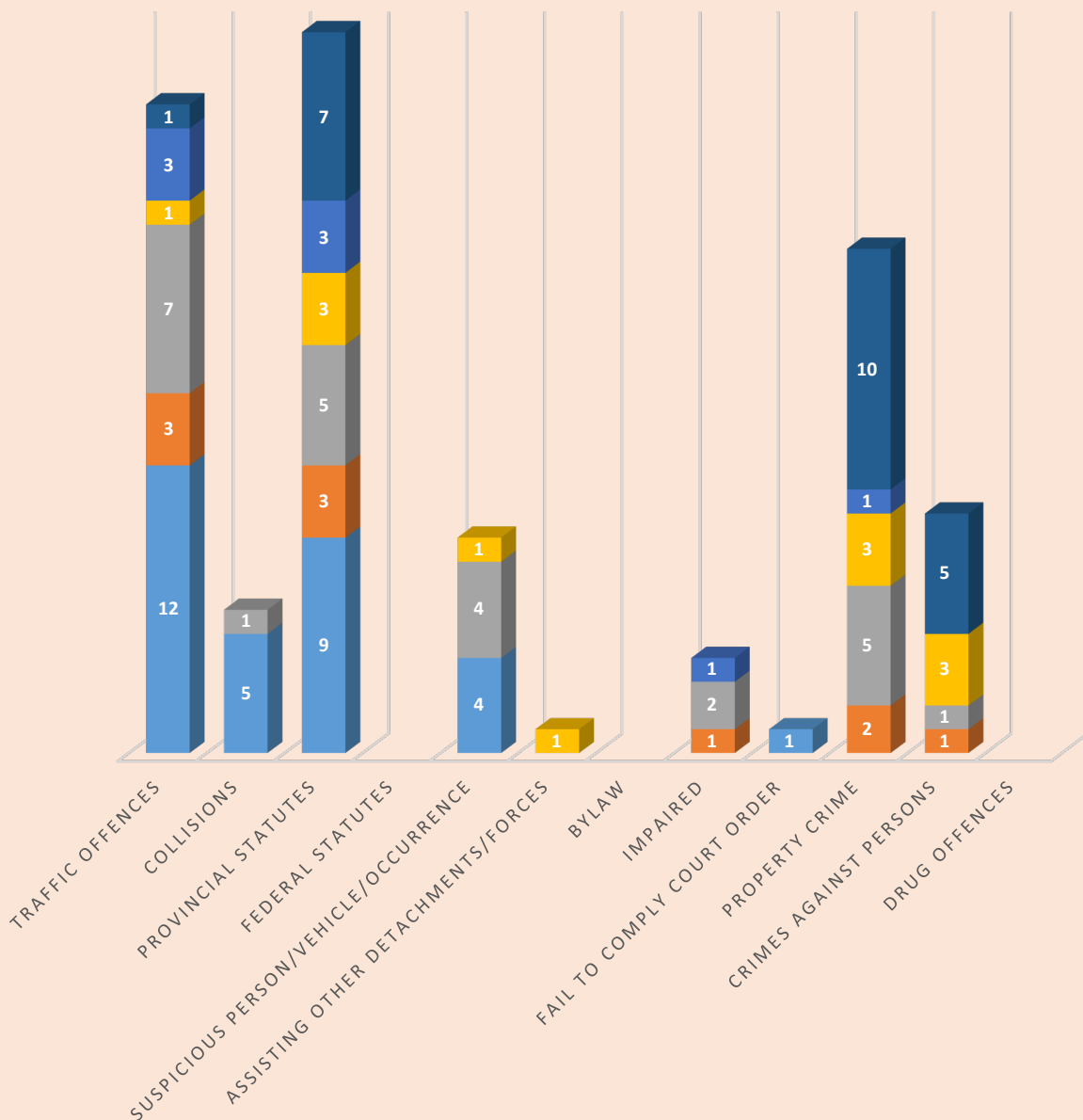

WHAT WENT ON LAST WEEK?

On April 18, the Turner Valley Fire Department extinguished a grass fire on town property on the west side of Decalta and Main Street. The RCMP investigation indicates that the grass fire was started by unknown suspect(s) playing with fire at a nearby fort. No suspects have been identified at this time.

On April 19, a vehicle was stolen from a residence on 274 Avenue in Foothills County. The vehicle was recovered in Calgary on April 21. No suspects have been identified.

On April 19, RCMP and emergency services attended a tipped over semi tractor and trailer on hwy 2 and hwy 547. Strong wind gusts were a contributing factor to the incident; there were no injuries and no charges are being laid.

On April 19, RCMP responded to an attempted vehicle theft in progress in Black Diamond. With the help of a witness, RCMP members located and arrested the suspect nearby. Draydon Clinton of Calgary has been charged with mischief, possession of break in instruments, and fail to comply with probation order. He is scheduled to appear in court on May 24.

On April 20, Foothills County RCMP received a report of a scam, where a Calgary resident had received a phone call that their son, a Foothills County resident, had been in an accident and needed \$8900 cash sent to his attorney immediately via UPS. The victim had sent the funds then called police to verify. RCMP coordinated with UPS to prevent the delivery and return the funds to the victim. The investigation to identify suspects is ongoing.

On April 20, Foothills County RCMP responded to a complaint of assault at the Eden Valley First Nation. Following a thorough investigation, seven charges were laid against a 25 year old female, including assault, child abandonment, dangerous operation of a motor vehicle, flight from police, and resist arrest.

On April 21, RCMP charged a 24 year old male with assault with a weapon after he assaulted a victim with bear spray on the Eden Valley First Nation.

On April 22, Foothills County RCMP members arrested a driver on 338 Avenue who had fled from Calgary Police earlier in the evening. The driver was turned over to Calgary Police and vehicle was

On April 27, Foothills RCMP received a complaint of two males that had door knocked at a residence in Black Diamond, claiming to be fibre optic installers with Telus, however Telus has advised they had no installers in the area. If you have a similar encounter, please call police immediately.

On April 26, a residence near Priddis was broken in to and several items were stolen. Suspects have been identified and the investigation is ongoing.

On April 27, Foothills County RCMP responded to a complaint of a suspicious vehicle. The response led to a male with a revoked firearms license in possession of two firearms. Mark Jones (57) of Calgary was arrested and charged. firearms were seized, and his vehicle towed.

On April 27, Foothills Emergency Services responded to a fatal two vehicle collision on Hwy 7 west of Big Rock Trail. The cause of the collision remains under investigation.

On April 30, Foothills County RCMP responded with emergency services to a collision on hwy 2 and 338 Avenue. A vehicle crossing hwy 2 while eastbound 338 Ave had been struck by two northbound vehicles. EMS transported two patients to hospital with minor injuries. The investigation is ongoing to determine if charges will be laid. Thank you to the Alberta Sheriffs who assisted on scene.
